GOVERNMENT RELATIONS

As the new year approaches, many offices will begin discussing who and how many will attend the AACRAO Meeting. This meeting should get special attention from anyone who is interested in politics and government relations. AACRAO will be honored this year to have former Secretary of State Madeline Albright as the closing speaker. A national icon and best-selling author, Albright became the first woman to serve as US Secretary of state. Albright will round out a conference that will be full of sessions on government relations and politics including:

- The influence of the Pell Grant on Proprietary Enrollment: A Panel Data Analysis
- Federal Program Review -- It Goes Beyond Financial Aid
- Using the Joint Services Transcript (JST) and the ACE Military Guide
- Higher Education Reauthorization Act and the Registrar's Office
- State-Funded or State-Subsidized and the Implications for a Registrar's Office
- Tail Wagging the Dog: Federal Financial Aid Regs and the Academic Record
- Is your Military and Veterans Education Benefits unit Ready?
- The status and impact of State Authorization Requirements and Reciprocity Agreements (SARA)
- Steps One University Undertook to Ensure Return of Title IV Compliance
- DREAMers and the College Dream

As usual, the AACRAO conference is an opportunity to not just learn more or get a refresher on FERPA but to also delve into some of the more specific implications, interpretations, and applications of the law. In addition to the usual FERPA updates and introductions, this year's conference will feature FERPA topics such as:

- FERPA and Vendors: Is Your Vendor Compliant?
- Your role as a FERPA leader on campus
- I understand FERPA, but how do I apply it when it's hard to do so?
- FERPA for Admissions Professionals.


COLLEGE CREDIT PLUS

College Credit Plus (CCP) replaces Ohio's Post-Secondary Enrollment Options program (PSEO) and all alternative dual enrollment programs previously governed by Ohio Revised Code Chapter 3365. Governor Kasich signed H.B. 487 into law on June 16, 2014. CCP program is operational for 2015/16 school year.

REQUIRES TWO FUNDAMENTAL CONDITIONS:

- 1. Student must be enrolled in both college and high school
- 2. Student to earn transcripted college and high school credit upon successful completion of the course
